We are delighted to conduct the campus recruitment process for Aspire program at **Govt Degree College Kargil**. The Aspire program is open to all the students who will graduate in the year 2026 in any stream. (Please note that students pursuing **integrated** degree courses, postgraduates, Law courses, etc. and part time are not eligible, only **Full time courses**).

- Willing to relocate across India

We will open online application for students on our website on 16-05-2026. Please find attached the presentation used for the pre-placement talk for your reference. Kindly share it with the students and advise them to **apply for the program by 03-06-2026 and complete the aptitude test by 15-06-2026**. Please note that we will be considering the applications through our portal only. As discussed, we intend to conduct the final interviews in-person on 25-06-2026, at campus.

Instructions for applicants

The selection process will be in-person and requirements for conducting the process are as follows:

1. **Online Applications:** We will open online application for students on our website on 16-05-2026. Please ensure that the students apply before the deadline. The steps to apply online are as follows:

Upon opening the application page (Link given at the bottom) Click on "Apply". We will recommend that applicants use personal email id for registration rather than the email id provided by the college

- In case if the applicant had already applied in the past on our portal, they can log in using their existing mobile number and OTP. **The applicants who already have an applicant ID, will have to submit the application after making necessary changes and then go to the declaration tab to submit the declaration which is a mandatory step**
